

Tuition Agreement

Thank you for your interest in Campbell County Schools. Parents/Guardians of non-resident students in grades seven through twelve (7-12) may apply for tuition status by completing a Tuition Application and submitting a \$50 non-refundable application fee. Submitting an application does not guarantee admission to Campbell County Schools. The tuition application process is highly competitive. No elementary students (K-6) will be accepted as tuition students.

Tuition students will be accepted provided:

1. Space is Available – (a) projected enrollment plus (b) room for growth in each school boundary does not exceed state cap sizes.
2. Academic Performance – at or above grade level as determined by district admission tests, as applicable, and student transcript from an accredited public or parochial school.
3. Behavior – the student must not have been suspended, expelled, or in the midst of such disciplinary action from any school prior to completing the application.
4. Attendance – regular school attendance and not exceeding six (6) unexcused absences during the previous school year.
5. Tuition Payment Obligation – the parent/guardian agrees to pay the annual tuition rate and excess Average Daily Attendance obligation if applicable. If financial terms are not met, the student will be withdrawn from Campbell County Schools. Failing to meet payment terms can result in payment in full for subsequent enrollments (by August 1 prior to the start of the school year), or the student will not be re-enrolled as a tuition student.

By completing the application process, the parent/guardian agrees to the following:

1. Campbell County does not have school choice.
2. Parents/Guardians are responsible for providing transportation to and from the school. Bus service is not available for tuition students.
3. Tuition students are not accepted after the start of the school year.
4. It is the parent's/guardian's responsibility to verify your district of residence. You will be charged the maximum tuition rate if your school district does not release ADA (Average Daily Attendance). If the cost to educate the student exceeds the ADA and the sending district does not enter into an agreement to reimburse Campbell County Schools the excess charges, then the parent/guardian agrees to reimburse Campbell County Schools.
5. Due to the transient shift in population during the summer months, you will be notified of your acceptance as a tuition student no later than August 1.
6. Applications for tuition status are required between March 30 and August 1. Applications received approximately August 1 will require a notification date beyond that period.
7. If a student does not meet satisfactory academic, behavior, attendance, and financial requirements, the student will not be permitted to return as a tuition student the following school year.

- 8. You authorize the sending school district to fully disclose all enrollment, assessment, attendance, and disciplinary records, in addition to other records as deemed necessary by Campbell County Schools.
- 9. You understand that providing false information shall be grounds for revoking tuition status.
- 10. Athletic eligibility is determined by the KHSAA guidelines for grades 9-12.
- 11. Employee children living out-of-district are permitted to attend according to Board policy.

To complete the application, submit the following requirements:

- 1. Letter of interest in having your child attend Campbell County Schools
- 2. Copy of your child’s prior grades / report cards / transcript
- 3. Any prior achievement test scores (state assessments, etc.)
- 4. Discipline records
- 5. Any supporting materials that may be relevant to the application
- 6. Non-refundable \$50 application fee
- 7. Application form(s)
- 8. Sign this form and return it along with the application materials. A copy will be returned to the parent/guardian.

Tuition Agreement for the **2020-2021** school year.

To ensure your child’s enrollment in the Campbell County School District during the **2020-2021** school year, a signed copy of this agreement must be received at the above address no later than August 1, 2020. The tuition rate for your child to attend Campbell County Schools during the 2020-2021 school year is \$6,668 (full tuition) and \$2,757 (partial tuition with release of ADA).

PAYMENT

Payment in full is expected by the first day of the school year. However, a 50/50 payment arrangement may be requested by checking and initialing below. In instances where a 50/50 arrangement has been granted, payment is due in two (2) equal payments due August 10, 2020 and January 1, 2021. The payment shall be considered late if it is not received by the 15th of each of these months. In such cases, a \$25.00 late fee will be added to that month’s payment. Additionally, should any check be returned due to insufficient funds, there will be a \$25.00 service charge added to that payment. Full payment must be made IN ALL CASES by the end of the first semester or no later than January 15, 2021. In the event of court action to enforce this agreement, the district shall be entitled to its costs of collection, including reasonable attorney fees.

A signed copy of this agreement must be returned to Campbell County Schools even if payment is made in full. Your child will be unable to attend Campbell County Schools if this signed agreement and tuition are not received prior to the first day of school.
